



## **Brown Marmorated Stink Bug (BMSB) 2017-18 Season Mandatory Measures**

The Department of Agriculture and Water Resources has developed the following mandatory measures to manage the seasonal risk of BMSB infestations in sea cargo shipped from the United States and Italy.

### **Season dates**

The requirements are intended apply to target goods shipped from the United States and Italy between 1 September 2017 and 1 April 2018 inclusive.

### **Affected ports**

The mandatory measures apply to target cargo shipped from *all* ports in the United States, as well as any European ports which load cargo manufactured or stored in Italy after the commencement of the season.

### **Goods**

As per last season, new and used vehicles, vessels and high risk machinery and parts are the target cargo for the mandatory measures. See Table 1 below for the list of affected tariffs.

### **Mandatory measures**

- From **1 September 2017** all **used** goods in the target tariffs must be cleaned and then treated for potential BMSB infestation immediately prior to shipping to Australia on or before **30 April 2018**. This applies to break bulk and FCL/FCX containerised goods.
- All **new** goods in the target tariffs manufactured and/or stored between **1 September 2017** and **1 December 2017** and then shipped as break bulk or FCL/FCX on or before 30 April 2018, must also undergo offshore treatment unless subject to alternative safeguarding arrangements approved by the Department of Agriculture and Water Resources.
- All **new** goods in the target tariff groups **manufactured after 1 December 2017** and shipped as break bulk or FCL/FCX on or before 30 April 2018 will require a consignment specific manufacturers' 'new, unused and not field tested' (NUFT) declaration which also includes the date and place of manufacture.

### **Effective Treatments**

The recommended treatments for BMSB remain unchanged from the previous season and are as follows:

- **Sulfuryl fluoride** – at least 48g/m<sup>3</sup> for 6 hours or longer or at least 16g/m<sup>3</sup> for 12 hours or longer both with an end point reading of 50 per cent or more of the initial concentration and conducted at a temperature of 10 °C or higher (please note this temperature is 5 °C lower than the methyl bromide conditions below).
- **Methyl bromide** – at least 16g/m<sup>3</sup> for 12 hours or longer with an end point reading of 50 per cent or more of the initial concentration and conducted at a temperature of 15 °C or higher (please note this temperature is 5 °C higher than the sulfuryl fluoride conditions above).

- **Heat** – 50 °C or greater for at least 20 minutes. The minimum temperature of the coldest part of the treated good should reach at least 50 °C for at least 20 minutes.

#### **Treatment window before loading**

- Break bulk goods treated **before 1 December 2017** have a 96 hour treatment window.
- Break bulk goods treated **after 1 December 2017** are unlikely to become re-infested, so they are not subject to a treatment window.
- Containerised goods sealed in the container immediately after treatment are not subject to a treatment window.

#### **Additional verification**

In addition to the above, additional verification activity targeting BMSB beyond the current standard verification activity, will be conducted throughout the BMSB season for specific goods from United States and Italy, as well as other emerging BMSB countries. DAWR will publish further details of proposed BMSB verification activities on its website shortly.

#### **Alternative arrangements—safeguarding**

Safeguarding is a detailed pest risk management plan/system that can be implemented by industry offshore in consultation with the department. Safeguarding arrangements are used as an alternative to the mandatory pre-shipment requirements, or other regulatory interventions on the goods on arrival in Australia. A list of safeguarding arrangements with the department will be made available online.

#### **Charging**

All charges for the department's services in documentary processing, risk assessments and inspections will be directed to the owner/importer of the goods, using the existing entry management processing for all imported goods.
